Item 1(a) Name of Issuer

The name of the issuer to which this filing on Schedule 13G relates is Pharvaris N.V. (the “Issuer”).

Item 1(b) Address of Issuer’s Principal Executive Offices

The principal executive offices of the Issuer are located at J.H. Oortweg 21, 2333 CH Leiden, the Netherlands.

Item 2(a) Name of Person Filing

This Schedule 13G is being filed jointly by Bain Capital Life Sciences Fund, L.P., a Cayman exempted limited partnership (“BCLS”), and BCIP Life Sciences Associates, LP, a Delaware limited partnership (“BCIPLS” and, together with BCLS, the “Reporting Persons”).

Bain Capital Life Sciences Investors, LLC, a Delaware limited liability company (“BCLSI”), whose managers are Jeffrey Schwartz and Adam Koppel, is the general partner of Bain Capital Life Sciences Partners, LP, a Cayman exempted limited partnership (“BCLSP”), which is the general partner of BCLS.

Boylston Coinvestors, LLC, a Delaware limited liability company (“Boylston”), is the general partner of BCIPLS. BCLSI governs the investment strategy and decision-making process with respect to investments held by BCIPLS.

As a result, each of BCLSI, Mr. Schwartz and Dr. Koppel may be deemed to share voting and dispositive power with respect to the securities held by the Reporting Persons.

The Reporting Persons have entered into a Joint Filing Agreement, dated February 19, 2021, pursuant to which the Reporting Persons have agreed to file this Schedule 13G jointly in accordance with the provisions of Rule 13d-1(k)(1) promulgated under the Act.

As of the date hereof, BCLS holds 2,885,266 Ordinary Shares, representing approximately 9.1% of the Issuer's outstanding Ordinary Shares, and BCIPLS holds 295,335 Ordinary Shares, representing approximately 0.9% of the Issuer's outstanding Ordinary Shares.

As a result of the foregoing and the relationships described in Item 2(a), the Reporting Persons may be deemed to collectively beneficially own an aggregate of 3,180,601 Ordinary Shares, representing approximately 9.9% of the Issuer's outstanding Ordinary Shares.

The percentage of the Issuer's outstanding Ordinary Shares held by the Reporting Persons is based on 31,839,776 Ordinary Shares issued and outstanding immediately following the closing of the Issuer's initial public offering on February 9, 2021, as reported by the Issuer in its Prospectus filed with the Securities and Exchange Commission (the "SEC") pursuant to Rule 424(b)(4) under the Securities Act of 1933, as amended, on February 8, 2021.
