Explanation of Responses:

- Includes restricted stock units previously granted under the Company's equity plan that remain outstanding as of March 18, 2026. The awards settle in shares of common stock and are reported in Table I as non-derivative securities. Vesting occurs as follows: -5,500 RSUs from an award granted March 3, 2026 of which 100% will vest March 3, 2027.
- 100% of the option vest on the 12-month anniversary.
- 25% of the option vested on April 6, 2024 with the remaining shares vesting in 1/48 monthly installments thereafter.
- 25% of the option vested on April 1, 2023 with the remaining shares vesting in 1/48 monthly installments thereafter.
- 25% of the option vested on February 5, 2022 with the remaining shares vesting in 1/48 monthly installments thereafter.
- 25% of the option vested on January 1, 2022 with the remaining shares vesting in 1/48 monthly installments thereafter.
